



**PUBLIC NOTICE**

**DECLARATION OF INTENT TO CHANGE WATER, WASTEWATER AND WATER SUPPLY RATES**

**Implementation of new Water, Wastewater and Water Supply rates on or about January 1, 2006 is hereby declared.**

Pursuant to the notification requirements of Title 30, Section 291.22 of the Texas Administrative Code and applicable City regulations, the San Antonio Water System (SAWS) Board of Trustees announces its intent to seek approval from the City of San Antonio City Council for the implementation of new Water, Wastewater and Water Supply Rates.

The new rates, as proposed by SAWS staff, will be presented for review at the October 18, 2005 meeting of the SAWS Board of Trustees; then for final consideration at the November 1, 2005 meeting of the SAWS Board. The water, wastewater and Water Supply rates ultimately approved by the SAWS Board are scheduled for review and consideration by the San Antonio City Council on November 3, 2005; then for final consideration on November 17, 2005. Upon approval by City Council, the new rates will become effective for billings on or about January 1, 2006.

The charts below and on page 2 represent samples of comparisons of current and proposed billing amounts for consumption of 10,000 and 30,000 gallons of water; and 10,000 gallons of wastewater for varying customer classes. #### Definitions

**Seasonal Period:** Time of year between July 1 and October 31

**Standard Period:** Time of year between November 1 and June 30

**ICL:** Inside City Limits

**OCL:** Outside City Limits

**General Class:** Includes commercial, industrial and apartment customers

**Base Consumption:** 90% of average monthly consumption of prior year

**Average Winter Consumption:** The period of service during the three complete consecutive billing periods beginning on or after November 15 of each year and ending on or after the completion of three full billing cycles in March of each year. Wastewater bills are based on this average.
