# System 2020 WATER QUALITY REPORT CASTLE HILLS

This report is a summary of the quality of water San Antonio Water System (SAWS) provides its customers. The analysis was made by using the 2019 data from the most recent U.S. Environmental Protection Agency (EPA) required tests and is presented in this report. We hope this information helps you become knowledgeable about what is in your drinking water.

# **SOURCE OF DRINKING WATER**

The sources of drinking water (both tap water and bottled water) include rivers, lakes, streams, ponds, reservoirs, springs, and wells. As water travels over the surface of the land or through the ground, it dissolves naturally-occurring minerals and, in some cases, radioactive material, and can pick up substances resulting from the presence of animals or from human activity.

Contaminants that may be present in source water include:

**Microbial contaminants**, such as viruses and bacteria, which may come from sewage treatment plants, septic systems, agricultural, livestock operations, and wildlife. SAWS samples eight sites in the Castle Hills distribution system for bacteria each month, and no *E. coli* positives were found in our drinking water in 2019. There was one positive *E. coli* raw water sample for a well in the system following a total coliform positive in the distribution. The well was placed out of service, disinfected and re-sampled before being placed back into service. SAWS followed all public notice posting requirements for this positive sample.

**Inorganic contaminants**, such as salts and metals, which can be naturally-occurring or result from urban storm water runoff, industrial or domestic wastewater discharges, oil and gas production, mining, or farming.

**Pesticides and herbicides**, which may come from a variety of sources such as agriculture, urban storm water runoff, and residential uses.

**Organic chemical contaminants**, including synthetic and volatile organic chemicals, which are by-products of industrial processes and petroleum production, and can also come from gas stations, urban storm water runoff, and septic systems.

**Radioactive contaminants**, which can be naturally-occurring or be the result of oil and gas production and mining activities.

## WHERE DO WE GET OUR DRINKING WATER?

The source of SAWS Castle Hills drinking water originated as groundwater from the Edwards Aquifer. The Texas Commission on Environmental Quality has completed an assessment of your source water, and the results indicate that some of our sources are susceptible to certain contaminants. The sampling requirements for your water system is based on this susceptibility and previous sample data. Any detections of these contaminants will be found in this Water Quality Report. # **ALL DRINKING WATER MAY CONTAIN CONTAMINANTS**

## SECONDARY CONSTITUENTS

Many constituents (such as calcium, sodium, or iron), which are found in drinking water, can cause taste, color, and odor problems. The taste and odor constituents are called secondary constituents and are regulated by the State of Texas, not the EPA. These constituents are not causes for health concern. Therefore, secondaries are not required to be reported in this document, but they may affect the appearance and taste of your water. ## **HEALTH INFORMATION ABOUT LEAD**

If present, elevated levels of lead can cause serious health problems, especially for pregnant women and young children. Lead in drinking water is primarily from materials and components associated with service lines and home plumbing. San Antonio Water System is responsible for providing high quality drinking water but cannot control the variety of materials used in plumbing components. When your water has been sitting for several hours, you can minimize the potential for lead exposure by flushing your tap for 30 seconds to two minutes before using water for drinking or cooking. If you are concerned about lead in your water, you may wish to have your water tested. 
# **SPECIAL NOTICE**

**DEFINITIONS**

The preceding tables contain scientific terms and measures, some of which may require explanation.

AL (Action Level) – The concentration of a contaminant which, if exceeded, triggers treatment or other requirements which a water system must follow.

ALG (Action Level Goal) – The level of a contaminant in drinking water below which there is no known or expected risk to health. ALGs allow for a margin of safety.

**Avg (Average)** – Regulatory compliance with some MCLs are based on a running annual average of monthly samples.

**Level 1 Assessment** – A study of the water system to identify potential problems and determine (if possible) why total coliform bacteria have been found in our water system.

**Level 2 Assessment** – A very detailed study of the water system to identify potential problems and determine (if possible) why an *E. coli* MCL violation has occurred and/or why total coliform bacteria have been found in our water system on multiple occasions.

MCL (Maximum Contaminant Level) – The highest level of a contaminant that is allowed in drinking water. MCLs are set as close to the MCLGs as feasible using the best available treatment technology.

MCLG (Maximum Contaminant Level Goal) – The level of a contaminant in drinking water below which there is no known or expected risk to health. MCLGs allow for a margin of safety.

MFL – Million fibers per liter (a measure of asbestos)

**STATE WATER LOSS AUDIT** 

In the water loss audit submitted to the Texas Water Development Board for the time period of January through December 2019, San Antonio Water System lost an estimated total of 13,398,073,243 gallons of water through main breaks, leaks, inaccurate customer metering, theft and other causes.

MRDL (Maximum Residual Disinfectant Level) – The highest level of a disinfectant allowed in drinking water. There is convincing evidence that addition of a disinfectant is necessary for control of microbial contaminants.

MRDLG (Maximum Residual Disinfectant Level Goal) – The level of a drinking water disinfectant below which there is no known or expected risk to health. MRDLGs do not reflect the benefits of the use of disinfectants to control microbial contaminants.

mrem - Millirems per year (a measure of radiation absorbed by the body)

- NTU Nephelometric turbidity units (a measure of turbidity)

pCi/L – Picocuries per liter (a measure of radioactivity)

ppm – Parts per million or milligrams per liter (mg/L) or one ounce in 7,350 gallons of water

**ppq** – Parts per quadrillion or picograms per liter (pg/L)

ppt - Parts per trillion or nanograms per liter (ng/L)

**TT (Treatment Technique)** – A required process intended to reduce the level of a contaminant in drinking water

µmhos/cm - Micromhos per centimeter (a measure of conductivity)
