Fall back on lawn watering and save money

Here's a fun fall fact: In San Antonio, the day will be 80 minutes shorter on the last day of October than it was in September.

There are also more hours of darkness than

daylight. For many of your plants, this means they have less time to soak up the sun. So, they produce fewer leaves and their water needs are much lower than they were in summer.

And for your home water use, it signals the beginning of the season to save.

That's because you can dial down landscape watering for the year — and reap the benefit of a lower water bill just in time for the fast-approaching holiday season.

Many sprinkler system controllers have a

seasonal adjust feature to make it easier to shorten the irrigation cycles. As warm season turfgrass winds down its growing season, watering times can be reduced. A good rule of thumb is to reduce to 70% for October, 40% for

November, and turn it off completely in December, running it manually onceper-month in winter only in the absence of rainfall.

As temperatures begin to cool, it's also a good idea to switch turfgrass watering to the morning hours instead of evening. This helps prevent the risk of fungal

disease which can spread in wet grass overnight.

It's time to give watering a rest for the season. Your plants and wallet will thank you!

How much you're charged for your sewer service is up to you. Save water now, save money throughout 2026. It's as simple as turning off your irrigation system for the season.

SAWS sewer charges are based on your average winter water use. So, the less water you use from mid-November to mid-March, the lower your monthly sewer charge will be for the rest of 2026.

If you're still running your irrigation system at least once per week during the winter, you're making an expensive mistake.

Bottom line: Saving water now can add up to big savings throughout 2026.

Check the schedule

The chart shows the approximate start and end dates of the winter averaging period for each SAWS billing cycle. Your billing cycle is shown in the blue "Current Bill Summary" section on the upper left portion of your bill. SAWS will begin billing you at the newly calculated sewer rate in the month shown.

Understand your flood risk

Do you know if the area you live in is prone to flooding? The City of San Antonio Public Works Department can help you determine if you're at risk.

Using the Federal Emergency
Management Agency's
flood insurance rate
maps, Public Works can
show you basic flood
information including flood
zones, local drainage areas,
depths of flooding, flood-related
hazards and historical flood data.
They can also share with you the

areas of town that provide natural floodplain ecosystem functions.

If flood water affects your property, Public Works can investigate the problem to give property protection advice, including drainage improvement suggestions and guidance on financial assistance programs.
